RULES FOR DUMPING GARBAGE AT TOWN SHOP

****Surveillance cameras are in use. Unauthorized dumping may be subject to a \$250.00 fine****

- The gate is closed, but **not** locked-PLEASE close behind you when you leave.
- Brush & Trees are to be dumped up on the hill to the LEFT. **DO NOT DUMP LEAVES ON THIS PILE**
- Leaves & Grass are to be dumped up on the hill to the RIGHT. **DO NOT LEAVE GRASS & LEAVES IN BLACK PLASTIC BAGS. YOU MUST TAKE THEM WITH YOU.**
- Electronics Dumpster is located inside the gate. This is for TV's, computers, stereos, etc.
- Appliances should be dumped inside the gate in the scrap iron bunker
- Scrap Iron should be dumped inside the gate in the scrap iron bunker
- **NO TIRES ALLOWED AT ALL!**

If there are any questions whether you are allowed to dump something, please call 262-354-4611 BEFORE you dump.
