AUGUST 2025 Regular Meeting Minutes
Monday, August 11th 2025 at 5:00pm

- I. **Call to order:** Chairman Paul Goeglein called the meeting to order at 5:00 pm
- II. **Roll Call:** Chairman Paul Goeglein, Clerk Dawn Bauer, Commissioner Ron Auerbach, and Commissioner John Szivecz were all present.

- IX. **Operators Report:**
 - Mike stated that has the “No Parking” signs to put in front of the lift station, and will be doing that this week. He let the owner of Pickets know about the signs and asked if their employees are able to park there since they can move them immediately if needed.
 - Collection system; there was a few high temperature alerts at Autumns Rest which were pretty typical.
 - He is waiting to hear back from Rural Development for allocation of funds for the lift station pump replacements, and the sewer lining using the Town’s ARPA funds.
 - All the pumps at lift stations are running approximately 3-4 times longer than usual due to the large amount of rain. Run time is usually 2 hours per day and it was 70-80 hours in the last 2 days. Most of the water is coming from the manholes along the river.
 - Mike has tried to contact the owner of the campground several times over the last several months to discuss lift station pump upgrades, and extra water flow.
 - There was discussion about taking care of the mowing and spraying weeds. Ron said he would go down and spray weeds at the plant.
